

Leave a Legacy Gift in your Will

Budleigh Salterton and District Hospiscare is a local Charity that provides care to people with progressive life-limiting illnesses in the community of Budleigh Salterton, Woodbury and the surrounding villages, including East Budleigh, Otterton, Bicton, Colaton Raleigh, Yettington and Newton Poppleford. We value dying as an important part of living and believe that every day matters to people approaching the end of their lives. Our services are provided free of charge, with the support of the local community.

We are financially independent of the Hospiscare charities in Exeter, Exmouth & Lympstone and Sidmouth and do not receive any funds from the NHS or any other Government agencies or public bodies. So legacies are hugely important to us and, by leaving us a gift in your Will, you will help us look after future generations and underpin the future of our Charity.

Should you decide to leave a legacy to Budleigh Salterton and District Hospiscare, then thank you so much. You can choose to leave either a fixed amount, a specific item (such as jewelry or property) or a share of the residue of your estate. Unless a different wish is expressed, all legacy gifts will be applied for the general operating costs of the Charity. It is very simple and all you need to do is speak to your solicitor or legal adviser to incorporate appropriate wording in your Will or, if you have made a Will already, then in a Codicil to your existing Will. Please ensure that our full name, address and registered charity number 1162329 is stated. As we are a registered charity, your legacy gift will be exempt from Inheritance Tax. Your professional adviser may find the following wording helpful:

"I give [free of tax the sum of £ (insert fixed amount)]* [{all} OR {a share equal to (insert fraction or percentage)} of the residue of my estate]* [my (insert name and description of item)]* to Budleigh Salterton and District Hospiscare of Seachange (The Hub), East Budleigh Road, Budleigh Salterton EX9 6HF, Registered Charity number 1162329, to be applied for its general purposes and the receipt of a proper officer for the time being of Budleigh Salterton and District Hospiscare shall be a complete discharge to my Executors."
